

KICKBOXING

Any stand-up combative sport where competitors fight with kicks and punches for a knockout or multi-judge decision over scheduled rounds divided by rest periods. Throughout the 1980s, the STAR System World Kickboxing Ratings strictly distinguished between kickboxing which prohibited clinch-fighting and muay Thai which permitted clinch-fighting. STAR regarded kickboxing and muay Thai as different sports. Since that era, combative sports have become more broadly divided between kickboxing and mixed martial arts. Sanctioning bodies have embraced competition and established kickboxing titles under multiple rule formats. For the sake of the historic record, all prominent rule formats have

been indicated within ring record compilations.

Predominant Kickboxing Rule Formats

Without Clinch-Fighting

INTERNATIONAL – low kicks and footsweeps allowed, no clinch-fighting, no throws (i.e. freestyle, boxe française-savate, WKA style) **FULL-CONTACT** – no striking below the waist, no clinch-fighting, no throws, minimum or continual kick requirement (i.e. full-contact karate, American kickboxing, PKA style)

Clinch-Fighting Optional

EXPERIMENTAL – variable rule schemes from the early formative period of kickboxing (i.e. USKA, WSMAC, NKL), or special negotiated rules to enable a mix-match between contestants from otherwise different combative sports (i.e. kickboxer versus muay Thai fighter)

With Clinch-Fighting

ASIAN – low kicks and sweeps allowed, knees to body and legs allowed, limited clinch-fighting allowed, no throws (i.e. K-1, modified muay Thai, muay Euro, Japanese kick-boxing)

CHINESE – low kicks and sweeps allowed, knees to body and legs allowed, limited clinch-fighting allowed, throws and takedowns allowed (i.e. san shou, sanda)

THAI – low kicks allowed, knee and elbow strikes allowed, clinch-fighting permitted, no throws, scoring based on classic techniques (i.e. muay Thai, Thai boxing)

Official Outcomes

DECISION – three judges score for the winner

MAJORITY DECISION – two judges score for the winner

SPLIT DECISION – two judges score for the winner, one for the loser

DRAW - the judges score for both contestants evenly

MAJORITY DRAW – two judges score evenly

SPLIT DRAW – one judge scores for each contestant, one even

TDRAW – technical draw (fight stopped without basis for a decision)

KO - knockout

KICK-KO (KKO) - kick-knockout

KICK-TKO (TKKO) – technical kick-knockout

TKO – technical knockout

NO-CONTEST – outcome officially set aside

NO-DECISION – competitive bout conducted without judges

M-WIN – official draw or no-decision in which the contemporaneous media sports reporters express a dominant opinion about who won

STAR Equalization Findings

For purposes of world-rated kickboxing competition and record keeping, STAR equalization findings differentiated between amateur and professional bouts, excluded bouts from other related combative sports (boxing, muay Thai, grappling), as well as arbitrated any peculiarities that occurred in the early and unruly era of kickboxing's rapidly changing rules and uneven standards for fair competition. The STAR System had no interest in advancing one competitor over another and never interfered with a competitor's official kickboxing record beyond the aforementioned distinctions.

- *1 **Wallace v Lewis**: The sport's first Pay-Per-View broadcast. Although officially an exhibition, ISKA judges brought in scores of 67-67, 67-67 and 67-66 for Wallace. At age 46, Lewis weighed 199 pounds; at age 45, Wallace weighed 166 pounds. Wallace earned \$25,000; Lewis \$17,500.
- *2 **Lewis v Morrison**: Standard PKA rules with boxing gloves, no striking below the waist, and 8 minimum kicks required per round.
- *3 **Lewis v Scott**: 6 minimum kicks required per round. Final scores: Scott 17, Lewis 12.
- *4 **Lewis v Clay**, **Lewis v Limoz**: Competition conducted inside a boxing ring wearing Safe-T-Equipment.
- Lewis v Brodar: 10,000 spectators. Competition conducted on an open mat wearing Safe-T-Equipment. 3 by 2 minute rounds. A 3-punch rule prohibited

- more than three consecutive punches without a kick. Broadcast over ABC-TV's "Wide World of Entertainment" on 27 December 1974 at 11:30 p.m.
- *6 **Lewis v Thompson**: 2,500 spectators. 5-minute no-decision competition conducted wearing Safe-T-Equipment. Thompson abruptly quit the ring just before the end.
- *7 **Lewis v King 1 & 2**: Jesse King did not realize he was being counted out in the first round. Joe Lewis agreed to an immediate rematch. The confusion led some press coverage to identify the knockout as coming in round 2, other coverage in round 3.
- *8 **Lewis v Slocki**: Competition conducted on an open space hard floor, originally intended as a no-decision demonstration match. Under formal sanctioning rules, back-to-back bouts would not be permitted, especially bouts after a knockout. Lewis regarded this meeting as double knockouts. Slocki called it a demonstration. They were both correct. For the record books during this early phase of the sport, however, knockouts become official even with no-decision demonstration bouts.
- *9 **Lewis v Daniel**: Ed Daniel stood 6 foot 6 inches and weighed 285 pounds compared with Joe Lewis at 5 foot 11 inches and 195 pounds. Both men received their black belts in Shorin-ryu karate from Eizo Shimabuku in Okinawa, though at different times. A Dallas police officer and karate instructor, Daniel also had a background in amateur boxing and professional wrestling.
- *10 **Lewis v Baines**: As suggested by Kenpo master Ed Parker, the rules included kicking, punching, knees, elbows and footsweeps. Only crescent and round kicks were allowed to the head. Striking-and-holding and hitting-below-the-belt were prohibited. 4 by 3-minute rounds were scheduled inside a boxing ring with 12 ounce boxing gloves, barefoot or with elective gym shoes. Isshin-ryu black belt Steve Armstrong of Tacoma, Washington, refereed. Lewis received a standing ovation from the 6,000 spectators in the audience. The United States Kickboxing Association (USKA) sanctioning body was originally called the Professional Karate Association for this event; it had no relationship whatsoever with the subsequent PKA founded in 1974.
